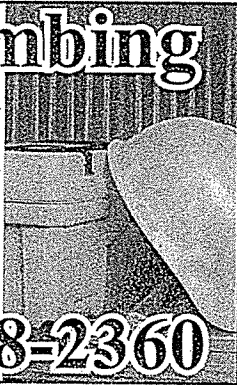

NOTICE OF PROPERTY TAX INCREASE

The Walker County Commissioner has tentatively adopted a millage rate which will require an increase in property taxes by 0.11 percent in the unincorporated area and 1.35 percent in the incorporated areas.

All concerned citizens are invited to the public hearing on this tax increase to be held at the Walker County Courthouse Annex III, 201 South Main Street, LaFayette, GA on August 23, 2018 at 6:00 p.m.

Time and places of additional public hearings on this tax increase are at the Walker County Civic Center, 10052 North Highway 27, Rock Spring, GA on August 30, 2018 at 10:00 a.m. and the Walker County Courthouse Annex III, 201 South Main Street, LaFayette, GA on August 30, 2018 at 6:00 p.m. when the millage rate will be adopted.

This tentative increase will result in a millage rate of 9.838 in the unincorporated area and 13.330 mills in the incorporated area, an increase of 0.00 mills in the unincorporated area and 0.177 mills in the incorporated area. Without this tentative tax increase, the millage rate will be no more than 9.827 mills in the unincorporated area and 13.153 mills in the incorporated area. The proposed tax increase for a home with a fair market value of \$100,000 is approximately \$0.00 in the unincorporated area and \$7.64 in the incorporated area and the proposed tax increase for non-homestead property with a fair market value of \$75,000 is approximately \$0.00 in the unincorporated and \$6.03 in the incorporated area.
