

**RESOLUTION R-021-18**

**A RESOLUTION AUTHORIZING A REFERENDUM TO ALLOW SALES ON SUNDAYS MALT BEVERAGES, WINE, AND DISTILLED SPIRITS BY THE DRINK**

**WHEREAS**, sales of malt beverages, wine, and distilled spirits by the drink are currently lawful within the unincorporated area of Walker County; and

**WHEREAS**, sales of malt beverages, wine, and distilled spirits by the drink are currently subject to regulation on Mondays through Saturdays in the unincorporated area of Walker County by the governing authority of Walker County; and

**WHEREAS**, O.C.G.A. § 3-3-7(j) authorizes the governing authority of a county to allow sales of malt beverages, wine, and distilled spirits by the drink on Sundays between the hours of 11:00 A.M. and 12:00 Midnight, if such sales are approved by voter referendum.

**NOW, THEREFORE, BE IT RESOLVED** by the governing authority of Walker County, Georgia that the County Clerk is hereby authorized and directed to transmit this Resolution to the Elections Superintendent to issue the call for a voter referendum for the purpose of submitting to the voters of the county the question of authorizing Sunday sales of malt beverages, wine, and distilled spirits by the drink between the hours of 11:00 A.M. and 12:00 Midnight.

**BE IT FURTHER RESOLVED** that, upon receipt of this Resolution, the Elections Superintendent shall issue the call and shall conduct the election in the manner prescribed by O.C.G.A. § 21-2-540.

**BE IT FURTHER RESOLVED** that the Elections Superintendent shall cause the date and purpose of the election to be published once a week for four weeks immediately preceding the date of the election in the official organ of the county.

**BE IT FURTHER RESOLVED** that the Elections Superintendent shall cause the following language to be written or printed on the ballot:


“Shall the governing authority of Walker County be authorized to permit and regulate Sunday sales of distilled spirits or alcoholic beverages for beverage purposes by the drink?”

**BE IT FURTHER RESOLVED** that upon the passage of the Sunday sales referendum, the governing authority of Walker County shall be authorized to permit and regulate sales by the drink of malt beverages, wine, and distilled spirits on Sundays between the hours of 11:00 A.M. and 12:00 midnight effective December 1, 2018.


