### Inspection Comments

Upon arrival I met with Shelter Director, Emily Sadler, to perform an unannounced investigation of the above listed facility. I walked facility inspecting premises, animals, and their enclosures. Facility was clean and in good state of repair. There was a current GDA Animal Shelter License with an expiration date of 01-31-2020. There were fire extinguishers on property. All animals appeared to be receiving humane care. All animals appeared to have space to move about freely and appeared to be separated adequately. All animals had access to water. One dog was housed in quarantine to for apparent mange (no confirmed testing) during inspection – it was housed alone.

There was one pony housed on property during inspection. It appeared to have access to lush grass, shelter, and water during inspection.

I did not check records during inspection. I will email inspection to Commissioner Whitfield and Shelter Director.
