



**RESOLUTION R-006-24**

**A RESOLUTION OF THE WALKER COUNTY BOARD OF COMMISSIONERS TO DESIGNATE AND APPROVE A DEFINED GEOGRAPHICAL AREA FOR A FIRE DISTRICT TO BE OPERATED BY THE MCLEMORE VOLUNTEER FIRE DEPARTMENT, INC.**

**WHEREAS**, fire protection is of vital importance to all citizens and visitors of Walker County; and

**WHEREAS**, McLemore Volunteer Fire Department, Inc. ("MVFD") is a registered non-profit corporation in good standing with the Georgia Secretary of State; and

**WHEREAS**, MVFD desires to provide fire protection to residents and visitors in a designated geographical area of Walker County as hereinafter further described in Exhibit "A" attached hereto ("Area"); and

**WHEREAS**, MVFD will have a fire station and fire equipment located within the Area and MVFD will have trained personnel to provide fire protection; and

**WHEREAS**, it is in the best interest of Walker County, its citizens and visitors, to designate and approve a defined geographical area for a fire district to be operated by MVFD; and

**WHEREAS**, MVFD is in the process of applying for a Certificate of Compliance with the Georgia Firefighters Standards and Training Council, and one of the requirements to obtain a Certificate of Compliance is to obtain a letter from the County governing authority approving MVFD to operate as a fire department within the Area; and

**THEREFORE BE IT RESOLVED**, by the Board of Commissioners of Walker County, Georgia, that the Chairman of the Board of Commissioners is authorized to execute a letter in the same, or substantively the same, form as attached hereto as Exhibit "A"; and

**BE IT FURTHER RESOLVED**, that the Area shall remain a part of the Walker County Fire and Rescue District, and an annual special assessment shall be charged on all structures located within the Area (except any public buildings and places of religious service). The Walker County Fire and Rescue District and the special assessment are defined in a County ordinance dated September 20, 1994, recorded in Minute Book 34, Pages 451-460; and as amended; and as may be amended in the future.

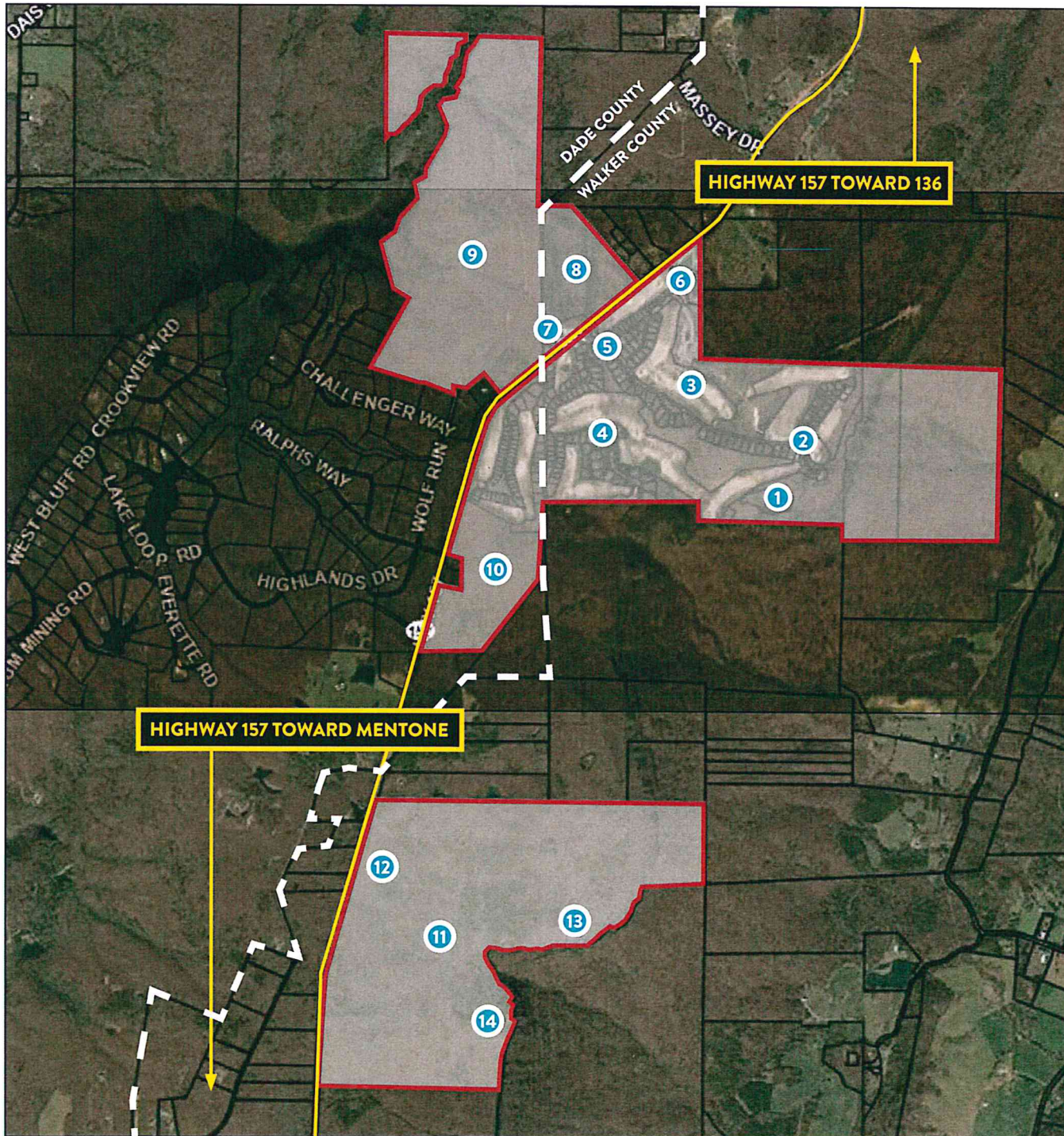

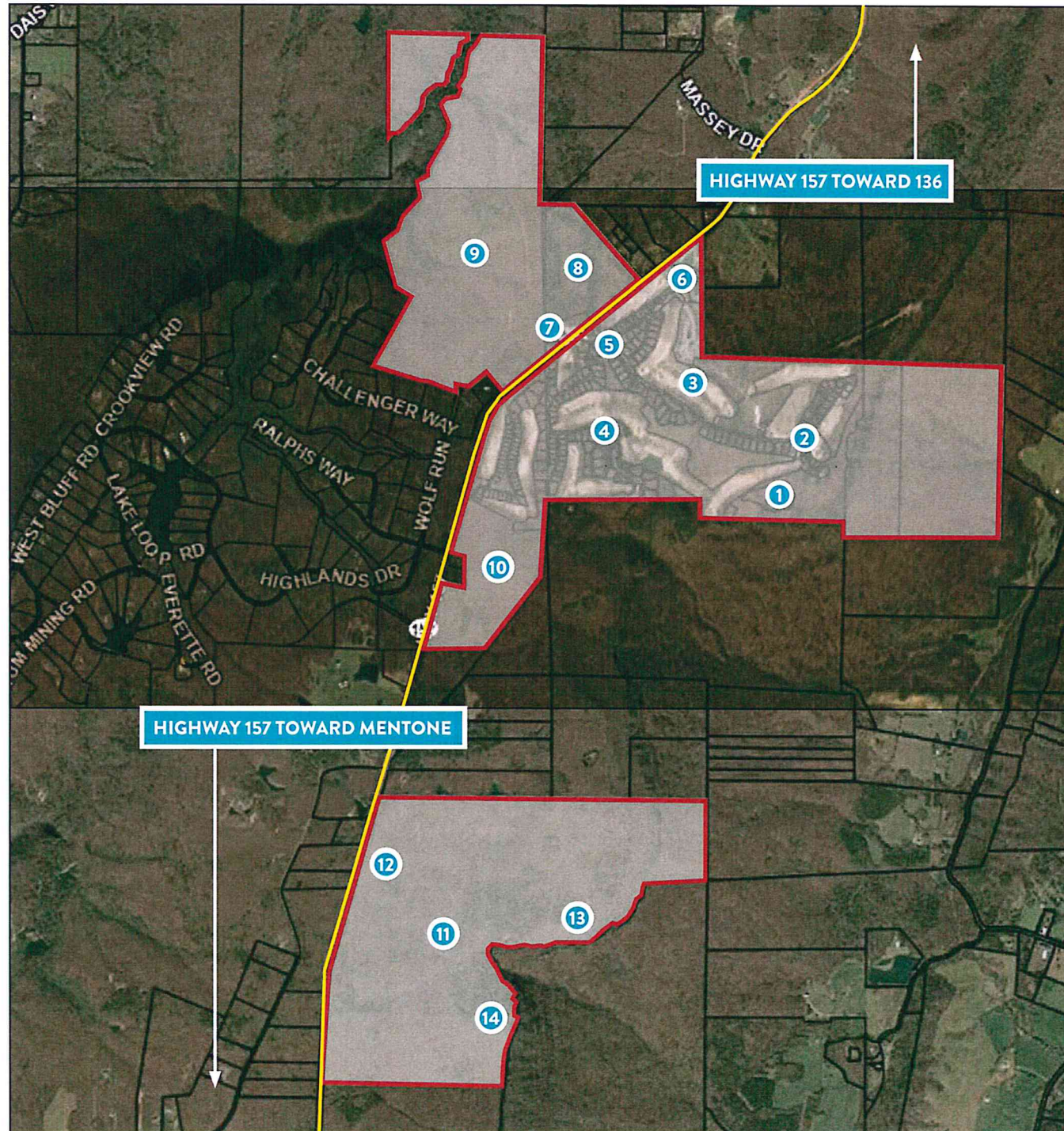


**FIRE SERVICES REFERENCE MAP FOR THE MCLEMORE RESORT**
