WHEREAS, the term of Steve Ledbetter, a Walker County member, set to expire on December 31, 2028; and



Jamie Bennett- for a term ending on December 31, 2028.


THEREFORE, BE IT RESOLVED by the Board of Commissioners of Walker County, Georgia that the appointment of Jamie Bennett is approved.
