A RESOLUTION OF THE WALKER COUNTY BOARD OF COMMISSIONERS TO AMEND THE FISCAL YEAR 2025 BUDGET TO APPROPRIATE FUNDS FOR THE WALKER COUNTY SHERIFF’S OFFICE

WHEREAS, the Board of Commissioners of Walker County (“Board”) is the governing authority of Walker County, Georgia; and

WHEREAS, O.C.G.A § 36-81-3 (d) requires any increase in appropriation at the legal level of control of a local government, whether accomplished through a change in expected revenues in any fund or through a transfer of appropriations among departments, shall require the approval of the governing authority by ordinance or resolution; and

WHEREAS, the Walker County Coroner’s Office is a legally constituted department of Walker County Government and is in need of funding to purchase a prisoner transport van, patrol vehicles, emergency equipment, radios, cages, striping and other miscellaneous items to outfit the Sheriff Department vehicles;

THEREFORE, BE IT RESOLVED that the Board of Commissioners of Walker County, Georgia hereby reallocates \$350,000.00 in the FY2025 budget out of the Sheriff’s Personnel Budget to the following general ledger numbers:
